*The Bilingual Research Journal* (BRJ) covers a wide range of topics relating to bilingual education, bilingualism in society, and language policy in education.

The editors request that manuscripts be a maximum of 30 computer-produced pages, double-spaced, in 12-point type, using 8.5 by 11 inch paper, with one inch margins, and American Psychological Association (5th edition) format for references.

Authors must submit a title page, and, on a separate page, a one paragraph abstract. The title page must include:

- 1) Full name author/s;
- 2) Conventional mailing address;
- 3) Email addresses;
- 4) Telephone numbers; and
- 5) Fax numbers.

The preferred way to submit manuscripts is to send them as electronic “attachments” to an e-mail message addressed to [kathy.escamilla@colorado.edu](mailto:kathy.escamilla@colorado.edu) or [maria.franquiz@utsa.edu](mailto:maria.franquiz@utsa.edu) .
