NATIVE CRAFTS TABLES AVAILABLE AT NABE 2010

NABE 2010, the 39th Annual International Bilingual/Multicultural Education Conference, will be held February 3-6, 2010 at the Denver Convention Center in Denver, Colorado. The conference will feature programs, products, and services for the nation's increasingly diverse student population. More than 5,000 teachers, school administrators, academic experts, policymakers, parents, and community members from all over the United States are expected to attend.

Native artisans are cordially invited to showcase and sell their work at NABE 2010. Only native crafts persons/artisans selling handcrafted goods may participate – no dealers or wholesalers are allowed. Native crafts tables will be located in the convention center exhibit hall. The schedule will be as follows:

For each payment of \$375, you will be provided with a space equipped with an 8-foot draped table, two chairs and two Conference badges. Please note the following conditions:

- Only one table is allowed per exhibit space purchased.
- All tables must be purchased through NABE; no additional tables may be used.
- All persons who will be staffing tables must wear a Conference badge.
- Multiple spaces may be purchased.
- Vendors will be responsible for setting up and dismantling their own displays.
- Displays must be contained within exhibit space purchased and may not be displayed anywhere else in the exhibit hall or convention center.
- NABE will be unable to provide any additional security for this area, so you should not leave any of your items unattended.

Full payment is required in advance by credit card, money order made out to the National Association for Bilingual Education – we are unable to accept installment payments. No personal checks will be accepted. Any contract received with partial payment will be returned unprocessed, and no space will be reserved for the vendor. You must submit signed contracts and payments by January 5, 2010.

CANCELLATIONS: Inability by an exhibitor to attend the show is not grounds for a refund by show management. Cancellation requests must be submitted to NABE in writing by January 5, 2010. Requests received in writing by January 5 will be subject to a 25% (of contract value) processing fee. Refund requests will be processed after the show.
